Stated below are the policies and procedures we are taking at Dawson Dance Academy due to COVID-19. Safety has always been our top priority. We are following the CDC guidelines given for dance studios, which we take very seriously and will strictly adhere to this school year. **PLEASE READ CAREFULLY:**

WHAT WE ARE DOING:

- All employees will wear a mask/face shield while in the building
- All employees will wash hands/sanitize upon entry to the building and regularly while in the building
- The temperature of all employees will be checked upon entry to the building
- Classrooms will be cleaned/sanitized between classes
- Class capacity will be limited
- Our lobby will be closed until further notice due to capacity/social distancing guidelines
- Water fountains will not be available
- Parent/guardian must call and be given permission before entering the building during class sessions
- If a parent/guardian must enter the building, they must have a mask/face covering on before entering

WHAT YOU CAN DO:

- Do not arrive more than 5 minutes prior to your child's class time
- Wait in the parking lot until it is time for your child to enter/exit the building
- Conduct self-assessment and do not let your child enter the building if they are exhibiting symptoms or have been exposed to COVID-19
- Have your child use the bathroom before attending class
- Your child should come with a water bottle with their name clearly on it and their dance shoes for class, nothing else

IN THE CASE OF QUARANTINE, THE FOLLOWING WILL APPLY:

- Classes will be provided weekly online, via YouTube, ZOOM, or another virtual platform
- The classes provided will continue on with technique/skills and/or choreography needed to continue their dance education
- You will continue to be billed on the 1st of every month per your Autopay Agreement
- There will be no refunds issued for tuition, uniforms ordered, or costumes _____ **(initial)**
